CONTEST RULES AND REGULATIONS

The competition is open to all high school juniors enrolled in participating schools within Planters Electric Membership Corporation's service area. Home-school juniors are also eligible but must reside in the primary residence served by Planters EMC. The following rules and regulations will be adhered to:

1. Any student who has previously won the Washington Youth Tour is not eligible to enter the contest.
2. Any student who is a son or daughter of a Planters EMC employee or director must enter the statewide Washington Youth Tour contest. Contact Randy Hill for details.
3. Each participant must be an "actively enrolled" junior in an accredited Georgia public or private high school or academy located in a county served by Planters EMC. Home-school juniors are also eligible but must reside in the primary residence served by Planters EMC.
4. All participants must be 16 years old at the time the tour takes place.
5. Each contest participant must submit a typed report using the printing format of Times New Roman, 12 point font with double spaced lines.
6. Each essay should be written on the topic provided. The length of the essay should not be less than 500 words but no more than 1,000 words.
7. The application form should be completed and attached to the essay.
8. Essays will be turned over to an independent panel of impartial judges who will evaluate each entry according to set criteria. Students should be advised that the judges will be giving consideration to such qualities as grammar, neatness, composition, originality, research, and knowledge of the subject. (Note: Students should simply follow the same methods utilized when writing a required report or term paper for a school class.)
9. Following the evaluation of all written work by the judges, a smaller group of finalists will be chosen. At this point, a personal interview will be held with each student on an individual basis. Interview judging criteria include knowledge, speaking ability, poise, personality and appearance.
10. The final decision on Planters EMC's three (3) representatives on the Washington Youth Tour will be based on the student's ability to communicate in writing as well as the ability to communicate "one on one."
11. All essays along with the "Washington Youth Tour Application" form attached as a cover sheet should be turned in at any Planters EMC office or received by mail addressed to: Randy Hill, Planters EMC, P.O. Box 979, Millen GA 30442-0979, no later than 5 p.m. on Monday, January 27, 2025.
12. All essays become the property of Planters EMC and may be used in EMC publications.
13. The 2025 Washington Youth Tour will begin on June 13, 2025 in Atlanta and conclude on June 20, 2025, also in Atlanta. All expenses (food, lodging, and airfare) with the exception of souvenirs will be covered by the EMC. Transportation to Washington, as well as the return trip, will be provided by one of the major airlines serving Atlanta's Hartsfield Jackson International Airport. Transportation to and from Atlanta will be the responsibility of Planters EMC unless the parent or guardian wishes to provide transportation for their son or daughter.
14. Planters EMC will award each 2025 Washington Youth Tour winner with a \$1,000 college scholarship. The scholarship will be submitted to their school of choice after the delegate graduates high school. The funds can be used for any educational expenses.
